MALAYSIA DAN ARAB SAUDI PERKUKUH KERJASAMA DUA HALA DALAM PENGAUDITAN SEKTOR AWAM

UNTUK SIARAN SEGERA

AKADEMI AUDIT NEGARA, BANDAR BARU ENSTEK, 5 September 2026 – Malaysia dan Arab Saudi hari ini memperkukuh kerjasama dua hala dalam pengauditan sektor awam menerusi pemeteraian Memorandum Persefahaman (MoU) antara Kerajaan Malaysia yang diwakili oleh Jabatan Audit Negara (JAN) dengan Kerajaan Arab Saudi yang diwakili oleh General Court of Audit (GCA), institusi audit tertinggi negara tersebut.

MoU tersebut ditandatangani oleh YBhg. Dato' Seri Wan Suraya Wan Mohd Radzi, Ketua Audit Negara, bagi pihak Kerajaan Malaysia dan TYT Dr. Hussam bin Abdulmohsen Alangari, Presiden GCA, bagi pihak Kerajaan Arab Saudi. Pemeteraian MoU ini turut disaksikan oleh TYT Osamah bin Dakhel R. Al-Ahmadi, Duta Besar Kerajaan Arab Saudi ke Malaysia. Turut hadir bersama pegawai-pegawai kanan Jabatan Audit Negara dan wakil daripada Kementerian Luar Negeri.

Majlis pemeteraian diadakan di Akademi Audit Negara, Bandar Baru Enstek, yang merupakan salah satu pusat latihan bertaraf antarabangsa di Asia yang diiktiraf oleh Pertubuhan Institusi Audit Tertinggi Asia (ASOSAI).

MoU ini merupakan memorandum persefahaman pertama yang dimeterai antara JAN dengan GCA sejak jalinan kerjasama mula dibina melalui penyertaan pegawai JAN dalam program pertukaran pengetahuan dan kepakaran anjuran GCA pada tahun 2024. Hubungan tersebut seterusnya diperkukuhkan melalui kunjungan hormat Presiden GCA kepada Ketua Audit Negara di Putrajaya pada 15 Ogos 2025 serta undangan khas Presiden GCA kepada Ketua Audit Negara untuk menghadiri Perhimpunan Agung ke-15 Pertubuhan Institusi Audit Tertinggi Arab (ARABOSAI) sebagai Tetamu Kehormat pada 2 hingga 4 Disember 2025.

Memorandum Persefahaman yang dimeterai hari ini merangkumi kerjasama dalam pengauditan kewangan dan prestasi, pertukaran pengetahuan dan kepakaran, latihan dan pembangunan kapasiti, penyelidikan bersama serta penganjuran seminar dan persidangan.

MoU yang dimeterai buat julung kali antara JAN dengan GCA ini mempunyai kepentingan strategik di peringkat Asia memandangkan Arab Saudi akan mengambil alih kepengerusian ASOSAI bagi penggal 2027 hingga 2030, manakala Malaysia akan menerima pelantikan sebagai Setiausaha Agung ASOSAI bagi tempoh yang sama dalam Mesyuarat Lembaga Pengelola ASOSAI Ke-63 yang dijadualkan berlangsung di Astana, Kazakhstan pada 16 hingga 17 September 2026.

Gandingan kerjasama antara JAN dan GCA ini akan membuka ruang untuk memperkukuhkan agenda pembangunan kapasiti, inovasi dan kecemerlangan pengauditan sektor awam di Asia, di samping memperluaskan jaringan kepakaran yang boleh dimanfaatkan bersama.

MALAYSIA AND SAUDI ARABIA STRENGTHEN BILATERAL COOPERATION IN PUBLIC SECTOR AUDITING

NATIONAL AUDIT ACADEMY, BANDAR BARU ENSTEK, 5 September 2026 – Malaysia and Saudi Arabia today strengthened bilateral cooperation in public sector auditing through the signing of a Memorandum of Understanding (MoU) between the Government of Malaysia, represented by the National Audit Department (NAD), and the Kingdom of Saudi Arabia, represented by the General Court of Audit (GCA), the country's Supreme Audit Institution.

The cooperation will strengthen the professional competencies of NAD auditors, broaden the exchange of expertise and support the use of technology in auditing, thereby improving the quality of public sector auditing and enhancing governance and accountability in the management of public funds in Malaysia.

The MoU was signed by YBhg. Dato' Seri Wan Suraya Wan Mohd Radzi, Auditor General of Malaysia, on behalf of the Government of Malaysia, and His Excellency Dr. Hussam bin Abdulmohsen Alangari, President of the GCA, on behalf of the Kingdom of Saudi Arabia. The signing was witnessed by His Excellency Osamah bin Dakhel R. Al-Ahmadi, Ambassador of the Kingdom of Saudi Arabia to Malaysia.

The signing ceremony was held at the National Audit Academy in Bandar Baru Enstek, one of the internationally recognised training centres in Asia accredited by the Asian Organization of Supreme Audit Institutions (ASOSAI). This is the first MoU concluded between the NAD and the GCA since cooperation between the two institutions was initiated through the participation of NAD officers in a knowledge and expertise exchange programme organised by the GCA in 2024. The relationship was further strengthened through a courtesy call by the President of the GCA on the Auditor General of Malaysia in Putrajaya on 15 August 2025, as well as a special invitation extended by the President of the GCA to the Auditor General of Malaysia to attend the 15th General Assembly of the Arab Organization of Supreme Audit Institutions (ARABOSAI) as Guest of Honour from 2 to 4 December 2025.

The MoU signed today encompasses cooperation in financial and performance auditing, the exchange of knowledge and expertise, training and capacity development, joint research, as well as the organisation of seminars and conferences.

This inaugural MoU signed between NAD and GCA holds strategic significance for public sector auditing in Asia, as Saudi Arabia will assume the Chairmanship of ASOSAI for the 2027 to 2030 term, while Malaysia will be appointed as the Secretary General of ASOSAI for the same term at the 63rd ASOSAI Governing Board Meeting, scheduled to be held in Astana, Kazakhstan, from 16 to 17 September 2026.

The collaboration between the NAD and the GCA will create opportunities to advance the capacity development, innovation and excellence agenda in public sector auditing across Asia, while expanding networks of expertise that can be shared and leveraged for mutual benefit.
